- I understand loan funds are not disbursed until 30 days into each semester
- I understand all loans require 2 disbursements. Loans requested for one term only will be disbursed in 2 separate, equal disbursements.
- I understand if I fail to meet the standards of Satisfactory Academic Progress, my loan will be cancelled.
- I understand if I withdraw completely before 60% completion of the term, I must repay a portion of my loan.
- I understand I am required to complete an online Loan Exit interview when I cease to be enrolled at least half time.

I request the amounts indicated above, and understand that the amounts may be adjusted due to my eligibility, which may be affected by my cost of attendance, other aid or assistance received, and my estimated family contribution, calculated by the Department of Education. I understand that the loan(s) will not be originated if I have not completed the Loan Agreement (MPN) and the Loan Entrance Counseling online.
