FCC's QM certification efforts are part of the college's Title III grant. Title III Grant director, Carol Dreith, says, "The overall goal of the Title III Grant is to increase student accessibility to Health Science courses through the establishment of online/hybrid content. FCC is committed to developing online/hybrid courses that are learner-friendly, organized, and follow best practices. The research-based Quality Matters program is internationally recognized as the premiere system for assuring quality in online courses and was selected [by Title III] to ensure the FCC courses were developed to meet stringent quality standards. Nixie Hnetkovsky's online Biology course is the first course at Frontier and the entire IECC district to earn the coveted QM certification."

Nixie Hnetkovsky, Life Science Associate Professor and Athletic Director, was thrilled with receiving this honor, saying, "I believe our students deserve the best [and the QM certification guarantees] excellence for online instruction. The QM certification mark is sure to serve as a badge of honor for Nixie, showing the world her desire and success in working to help FCC students. "The process for a course to become QM Certified is a very overwhelming process. There are 42 standards by which the course content is measured and scored. After the initial review, a [QM] report is provided for the instructor, and they are given 14 weeks to amend their course content. It takes months to complete the entire cycle."

Currently, one other course at FCC is under review for QM certification. After completing this review, the Title III team intends to apply the QM methods to other FCC courses that are migrating to a hybrid model. The future of education is increasingly digital. While FCC still has a robust offering of inperson classes, this addition of premier-quality hybrid courses will allow more students in the region to access the college's top-notch education.



## SPRINGING INTO ENROLLMENT

Spring enrollment opportunities are expanding at FCC with the changes to the Certified Medical Assistant(CMA) program. Curricular changes were made, allowing new students to enroll in either the fall or spring semester. Previously, if a student became interested in joining the CMA program after the Fall 10-day class change period, they would have to wait until August to enroll. The new reduced wait time allows students to start the program more conveniently and join their chosen career field sooner.

The new enrollment period for CMA is already shared with FCC's Automotive program, which has previously allowed students to enroll
