# **ADULT EDUCATION - Angel Maquire**

- 85 total completers and 327 unduplicated students enrolled in FY25
- 59 active Summer Session students.
- 23 graduates walked in July, Chika Koker was the Alum speaker, Jeremy Brush from ROE 12 was the keynote speaker, and several teachers.
   Preparing for the FY26 Graduation, 8 completers already this fiscal year.
- The Office of Management and Budget (OMB) has released IELCE funding and Adult Education Federal Funding with a new look and expectations for AE this fiscal year and going forward
- Co-Enrollment/ICAPS focus for FY26 goal is 25 students
- Focusing on employability and workforce skills, credential attainment, skilled workforce development, and economically sustainable futures. Industry recognized credentials are an expected outcome for adult education, via Integrated Education and Training (IET) and Pre-Apprenticeship Programs
