- Adult Education and Family Literacy Week September 14th 20th Once a year educators from all over the country join together with adult learners, community partners, business leaders, legislators, and friends of adult education to amplify their successes! - Working with Academic Affairs to monitor the students who have completed GED subtests with scores at-or-above above 175 for continued offerings of college credits in those subject areas.
